The Institute for Human Rights Working Paper Series is an online paper series covering a broad range of topics. The Series welcomes submissions on a broad range of international issues, primarily (but not exclusively) related to human rights. The purpose of the Series is to publish work in progress. The Series is published at irregular intervals. Contributions may for example be conference proceedings/papers, draft articles, or published texts which the author wishes to make available online (with the permission of the publisher). Submissions should however be complete papers/articles and of scientific interest. The editors reserve the right to reject proposals as well as to propose revisions.

The Working Paper Series is a non-peer reviewed open access publication. Submissions are published on the Åbo Akademi University Institute for Human Rights webpage. Copyright belongs to the author(s). The author is free to publish his/her contribution elsewhere, and in accordance with the Institute for Human Rights publication strategy, is encouraged to disseminate the paper through available open access platforms. There is no publishing fee and no publishing reward. Publishing in the Series does not give JUFO-points.

## Editorial Guidelines

Submissions should preferably be in the range of 5000-20000 words. The submission should constitute a self-standing text. The Series does not require a particular style of referencing, but recommends the use of well-established techniques such as OSCOLA.<sup>1</sup> Submissions are checked for consistency and ethical use of referencing.<sup>2</sup> Footnotes should be used instead of endnotes. The text should be submitted using the present template. Linguistic and substantive proofing is only provided in order to remedy serious flaws in the readability of the text. Author(s) are responsible for the linguistic correctness as well as the substantive content of the submission. The submission should include information about the author.
