Minority research profile is one of the four multidisciplinary research areas that Åbo Akademi University has chosen to focus on since 2015.

As a university serving the needs of Swedish speaking language minority in Finland, Åbo Akademi University possesses significant expertise in the field of minority research. The expertise has been built up during the University's more than 100-year existence. Minority research is interdisciplinary and includes several disciplines and thus several faculties.

The minority profile focuses on four thematic areas, including equal rights, discrimination, and democracy; minority identities and culture; minoritization processes and minority positions in history; culturally and linguistically responsive teacher education. The profile's focus is multidisciplinary and global. It includes both old and new minorities, as well as the processes by which minorities come into being and the kind of resistance that such processes generate.

With the support of the Academy of Finland, a recruitment process was initiated in 2015 for three tenure track positions in the new field of minority research. After an external expert evaluation and on the proposal of a recruitment committee, the Rector of Åbo Akademi University decided on 26.4.2016 to employ Doctor of Juridical Sciences Magdalena Kmak as Associate Professor in Minority Studies. She was employed for the period 1.6.2016-31.5.2020 with placement at the Faculty of Social Sciences, Business and Economics, later the Faculty of Social Sciences, Business and Economics, and Law.

Within the tenure track system, an associate professor is employed for four years, with the possibility of extension of two years. Upon successful evaluation and indisputably established professorial qualifications, the associate professor advances to the following level as a professor.

In 2019, the evaluation of Kmak's advancement to a professor was initiated. A recruitment committee, appointed by the Dean, included Docent Laura Hollsten (FHPT), Professor Marko Joas (Chair, FSEJ), Professor Peter Nynäs (FHPT) and Professor Markku Suksi (FSEJ). In January 2020, the Rector of Åbo Akademi University appointed Professor Emerita Maja Kirilova Eriksson (Uppsala University) and Professor Thomas Spijkerboer (Vrije Universiteit Amsterdam) as external experts to review Magdalena Kmak's competence as a professor.

Based on the expert's statement, the recruitment committee unanimously suggested to the Rector that Magdalena Kmak is indisputably qualified for a professorship in Public International Law, with a specialization in Migration and Minority Research. Rector enforced out the employment and as of 1 June 2020, the said professorship is held by Magdalena Kmak.

The research in the area focuses on the multifaceted relationship between law and mobility, in the context of global migration and minority regimes. Other research interests encompass new minorities, exile studies and history of migration, mobility studies, public international law, human rights and International and European refugee and migration law.

The professorship is the only one of its kind in Finland.

## Magdalena Kmak

was born in 1978 in Tarnów, Poland. In primary and secondary school, she was interested in Polish, Russian and English languages, and history but also in chemistry, mathematics, and informatics. She also really enjoyed classes in woodworking, cooking and sewing, all of which she still very much enjoys nowadays. In 1997 after graduating from the secondary school (III Liceum Ogólnokształcące im. Adama Mickiewicza w Tarnowie) she started the Law Studies at the Jagiellonian University in Kraków. During her studies she was particularly interested in human rights and migration law. For two years she worked at the Jagiellonian University Law Clinic (Human Rights Section) and the Human Rights Centre under the supervision of dr Halina Nieć. At the Law Clinic she provided legal advice to refugees and migrants and represented them before the relevant administrative institutions. Together with the Law Clinic team she also regularly visited the detention center in Lublin. Her Master's thesis focused on the International Standards of Protection of Rights of Persons with Disabilities.

After graduating from the University in 2002 she started working at the Helsinki Foundation for Human Rights in the Program of Free Legal Aid to Refugees and Migrants, where in 2007 she became the Program's coordinator. Together with the team of lawyers working under supervision of Professor Irena Rzeplińska she was involved in providing legal assistance to refugees and migrants, strategic litigation, acting as an expert in legislation procedures and for various ministries, monitoring of detention institutions, reception centres, prisons and mental health institutions, teaching, and lecturing. She established and co-coordinated the Helsinki Foundation Refugee and Migration Law Clinic. She also worked as a research assistant to Marek Antoni Nowicki, a Member of the EU Network of Independent Experts on Fundamental Rights. In 2007–2008 she worked as Legal Officer at European Council on Refugees and Exiles where she was involved in work on policy and law developments as well as in coordination of the European Legal Network on Asylum (ELENA).

In 2004 Magdalena started her doctoral research under the supervision of Professor Roman Wieruszewski at the Institute of Law Studies, Polish Academy of Sciences. She has defended her doctoral dissertation on the topic *International Standards on Expulsion of Foreigners and their Implementation in Chosen Countries* on 11 December 2009.

Before moving to Finland in 2008 Magdalena visited Åbo Akademi twice – attending the Advanced Course on the International Protection of Human Rights at the Institute for Human Rights in 2004 and in 2008 when she received CIMO Scholarship and spend 6 months at the Institute working on her doctoral thesis. After moving to Finland in 2008 she became a research fellow and later a postdoctoral researcher at the Erik Castrén Institute of International Law and Human Rights. At the Erik Castrén Institute she was involved in a number of projects including a study on *The Legality of Kosovo's*

*Declaration of Independence in Light of Advisory Proceedings at the International Court of Justice* as well as *The Scope and Application of the Principle of Universal Jurisdiction*, both commissioned by the Finnish Ministry for Foreign Affairs. She was also involved in other projects and initiatives such as the project *Equal Before the Law: Access to Justice in Central Asia* (a joint program of the Finnish Ministry for Foreign Affairs and the Eurasia Foundation) as well as the Helsinki Law Clinic. From 2013–2015 she co-directed together with Professor Dorota Gozdecka, the project titled *Law and the Other in Post-Multicultural Europe*, funded by the University of Helsinki Research Funding.

Between 2013 and 2015 Magdalena worked as the University Lecturer in International Law at the Faculty of Law at the University of Helsinki and between 2015 and 2016 as a postdoctoral researcher in the project *Reinventing the Foundations of European Legal Culture 1934–1964* (Foundlaw) at the Faculty of Social Sciences at the University of Helsinki, directed by Kaius Tuori.

In 2016 she has been chosen as one of the associate professors in Minority Studies at Åbo Akademi. She also took part in successful application for the *Centre of Excellence in Law, Identity and the European Narratives* (directed by Professor Kaius Tuori, Professor Pamela Slotte and Professor Reetta Toivanen) and in 2018 she became a Team Leader of the Subproject 3 *Migration and the Narratives of Europe as an “Area of Freedom, Security and Justice”* the position that she held until June 2022.

Magdalena has been appointed Professor of Public International Law, with a specialization in Migration and Minority Research in June 2020. Currently she is a Principal Investigator and Consortium Director of the project *Diversity, Trust and Two-Way Integration (Mobile Futures)*, funded by the Strategic Research Council within the Academy of Finland (2021–2027), which she currently co-leads together with dr Johanna Leinonen (UOulu), dr Saara Pellander and dr Tomas Hanell (MIF), dr Daniela Alaatinoglu (UTU), Professor Gunilla Widen, and Yasmin Samaletdin (ÅA). Magdalena is also a co-founder of the *Nordic Network on Climate Related Displacement and Mobility*.

Throughout her career Magdalena held visiting fellowships at the College of Law at the Australian National University, Free University of Amsterdam, University Roma Tre and the Center for the Study of Law and Society at University of California at Berkeley. She also was a board member of the Society for the Study of Migration and Ethnic Relations (ETMU), Nordic Migration Research and the Migration Institute of Finland. Currently she is involved in Scholars at Risk Finland Section and a member of the European Coordinating Committee for Academic Freedom Advocacy. She is also a member of the Scientific Advisory Boards for the Migration Law Research Centre at the Institute of Law Studies, Polish Academy of Sciences and KONE Funded research project *Endings – Refuge, Time, and Space* led by dr Eveliina Lyytinen at the Migration Institute of Finland.

These current research interests and research projects have been inspired both by Magdalena’s practical legal work and her work as a researcher. Her work initially focused on the human rights-based approach to migration. At the same time, while being involved in the practical application of these human rights standards in Poland



she developed a deep level of frustration linked to her own limitations as a lawyer, to put them effectively to work. The origins, purpose, and the way of resisting this “gap” between theory and practice of human rights or migrants and refugees have oriented her work ever since. After obtaining her doctoral degree she has shifted her approach from human rights-based approach towards the critical research methods and focused on the way how migration is managed through law, including through the human rights instruments. She wanted to understand the conditions of possibility for implementation of human rights of migrants and their way of operation in particular legal, political, and social circumstances. This required her to return to and look critically into such concepts as statehood and state sovereignty, citizenship, and borders. The questions she started to ask were: what is the relation of human rights to power? What citizen subjectivities are created through law? How does the concept of statehood and development of the modern nation-state contributed and contribute to the development of contemporary understanding of the migrant and the refugee? What types of refugee and migrant subjectivities are developed through law, including through human rights law? How migration law influences statehood and state sovereignty in the context of globalization? At the same time while working in the Foundlaw Project she became interested in the impact of migration and refuge experience on the production of legal knowledge and started to ask questions as to the role of the experience of exile and forced displacement on the development of legal knowledge.

These questions have oriented Magdalena’s approach to migration and mobility and have recently inspired two book projects: an edited volume titled *Refugees and Knowledge Production: Europe’s Past and Present* (Routledge 2022, co-edited with Heta Björklund) and the forthcoming monograph *Law, Migration and Human Mobility: Mobile Law* (Routledge).
