### **ELECTIVE STUDIES (40 credits)**

Students can freely choose courses up to 40 credits. These need not be, but can be, courses in public international law or human rights. Students can choose a Minor, which requires 25 credits in the chosen thematic area. Examples of thematic areas which offer Minors (25 credits) in English are: Minority Studies, Intercultural Communication, and Sustainability in Development (offered by the UniPID Network). There are also thematic modules (20 credits) in English, such as: EU studies, The Sea, and Gender studies. Elective studies may include work experience/internships (5 or 10 credits, depending on the length of the work experience/internship).
