Contributions may be full articles, but also, for example, conference proceedings or papers, draft articles, articles based on master's theses, or already published texts, such as reports which the author wishes to make available online (with the permission of the original publisher). Submissions should, however, be complete papers or articles and of scholarly interest. The editors reserve the right to reject proposals, and all contributions undergo editorial review.

Papers in the Working Paper Series are published open access on the Institute's webpage, as well as in the Doria repository (<https://www.doria.fi/>) (licensed under CC BY-NC-SA 4.0). Copyright remains with the author(s). The author is free to publish their contribution elsewhere, and in line with the Institute for Human Rights' publication strategy, is encouraged to disseminate the paper through available open access platforms. There is no publishing fee and no publishing reward. Publishing in the Series does not give JUFO-points.

Editorial Guidelines

Submissions should preferably be in the range of 5,000–20,000 words. The submission should constitute a self-standing text. The Series does not require a particular style of referencing but recommends the use of well-established techniques such as OSCOLA.¹ Footnotes should be used instead of endnotes. The text should be submitted using the present template which can be requested from the editors. Author(s) are responsible for the content of the submission, including compliance with principles of ethical research. The submission should include information about the author.
